1. Introduction

Thus, a statement in the 155th plenary meeting is indicated as Plenary:155, which corresponds to the mimeographed verbatim record A/PV.155. A statement made in the 52nd meeting of the Fourth Committee is indicated as IV:52, corresponding to the mimeographed summary record, A/C.4/SR.52.
