PART A. INTRODUCTION

1. General

Document A/INF/28, Addendum 1 and Addendum 2 (in preparation) constitute the Disposition of Agenda Items for the whole of the third regular session. For agenda items discussed in both parts of the session, the complete record is included in this document, so that the earlier record on these items in document A/INF/28 need not be consulted, except for Paris discussion concerning the agenda (item 7) and the admission of new Members (item 14).

The subject-index to statements for the entire third session will be published as document A/IRF/28/Add.2.

2. Check list of documents
